Dear Parent/Carer,

Re: Trip to Cadbury World, Birmingham

On **Wednesday 13 March**, we, as the geography department, are offering students the opportunity to go to **Cadbury World in Birmingham**.

This is an amazing opportunity to visit a global company at their headquarters and listen to one of their engaging speakers about how the company can link to what we are doing in the classroom. There are some hugely beneficial cross curricular links.

We will leave COPA at 9am so students need to come in for 8.35am as normal, register with their form tutor, before heading down to the canteen.

Once arriving at Cadbury World, there will be the opportunity to have an educational talk, from the company that will hope to cover these aims:

- Discover the global legacy of the Cadbury brand and their reach as a transnational company.
- Discuss how Cadbury is part of a larger company and the effect this has on international business.
- Examine Cadbury's place within primary, secondary and tertiary industries.
- Understand Cadbury's key markets and how Cadbury is developing new products to reach and mint countries.
- Explore the providence of some of our ingredients and how Cadbury are supporting cocoa farmers as well as the Ghanaian rainforest through schemes such as Cocoa Life.
- Compare the functions of the various Cadbury factories found in the UK and discuss the importance of location when choosing a factory location.
- Recognise the importance of sustainability in industry and discover the methods in which Cadbury are improving their environmental footprint.

Students, following the talk, will have lunch. **This should be a packed lunch, however, if your child has free school meals, this will be provided by the school.** After this, a self-guided tour of the factory, led by the teachers, will take place before heading back to COPA.

The proposed Itinerary of the day is as follows:

Timing	Activity
8.35am	Students arrive at school, get registered with their form tutor and then head down to the canteen to be registered by staff going on the trip.
9am	Departure from COPA.
11.15am	Arrive at Cadbury. Take part in an educational talk from Cadbury.
12.20pm	Have lunch.
12.50pm	Go on self-guided tour led by teachers.
2pm	End tour to go via gift shop.
2.30pm	Leave Cadbury world.
4.45/5pm	Arrive back at COPA.

Students will be allowed to wear non-school uniform for the day and students may keep their phone on them during the day. The expectation is that phones may be used on the journey to and from the attraction only, mainly for communication around return times. Of course, the timings set out above are approximate timings and communication will be made if there are delays.

The cost of the trip is £30 per person which covers the transportation costs as well as the entry into Cadbury world. Signing up to the trip should be done through this MS form:
